REQUEST FOR EXPRESSION OF INTEREST
BIR-COMPLIANT CLOUD BASED READ AND BILL ANDROID APPLICATION BILLING,
TELLERING AND CUSTOMER SERVICE SOFTWARE WITH
PAYMENT PARTNERS SYSTEM INTEGRATION
 (PDA2017-005)

1. The **Partido Development Administration**, through the *PDA Corporate Operating Budget for 2017* intends to apply the sum of **ONE MILLION SEVEN HUNDRED NINETY THOUSAND PESOS (P 1,790,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for **BIR-Compliant Cloud Based Read and Bill Android Application Billing, Teller and Customer Service Software with Payment Partners System Integration (PDA2017-005)**. Bids received in excess of the ABC shall be automatically rejected at the opening of the financial proposals.
2. The *Partido Development Administration* now calls for the submission of eligibility documents for **BIR-Compliant Cloud Based Read and Bill Android Application Billing, Teller and Customer Service Software with Payment Partners System Integration**. Eligibility documents of interested consultants must be duly received by the BAC Secretariat on or before **September 18, 2017, 2:00 P.M. at Partido Development Administration, Caraycayon, Tigaon, Camarines Sur**. Applications for eligibility will be evaluated based on a non-discretionary "pass/fail" criterion.
3. Interested bidders may obtain further information from *Partido Development Administration* and inspect the Bidding Documents at the address given below during *Monday to Friday from 8:00 A.M. – 5:00 P.M.*
4. A complete set of Bidding Documents may be acquired by interested Bidders on **September 11, 2017 until October 9, 2017** from the address below and upon payment in the amount of **Five Thousand Pesos (P 5,000.00)**.
5. The BAC shall draw up the short list of consultants from those who have submitted Expression of Interest, including the eligibility documents, and have been determined as eligible in accordance with the provisions of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act", and its Implementing Rules and Regulations (IRR). The short list shall consist of **three (3)** prospective bidders who will be entitled to submit bids. The criteria and rating system for short listing are:

CRITERIA	POINT SYSTEM
Applicable Experience of Consultants	30%
Qualification of Personnel Who May be Assigned to Job	50%
Current Workload relative to capacity	20%
TOTAL	100%

6. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the IRR of RA 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.

7. The Procuring Entity shall evaluate bids using the Quality Based Evaluation/Selection (QBE/QBS).

8. The contract shall be completed within ***three (3) months***.
