## INVITATION TO BID

### PUBLIC BIDDING

#### **SUPPLY AND DELIVERY OF 1,500 BAGS OF ALUMINUM SULFATE (PDA 2019-003)**

1. The **Partido Development Administration**, through the *PDA Corporate Operating Budget of 2019* intends to apply the sum of **TWO MILLION FOUR HUNDRED SEVENTY-FIVE THOUSAND PESOS ONLY (P 2,475,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for the **Supply and Delivery of 1,500 Bags of Aluminum Sulfate (PDA 2019-003)**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **Partido Development Administration** now invites bids **Supply and Delivery of 1,500 Bags of Aluminum Sulfate**. Delivery of Goods is required *50% of quantity within 30 days after receipt of Notice to Proceed and another 50% of quantity to be delivered after four (4) months*. Bidders should have completed a contract similar to the project within two (2) years from the date of submission and receipt of bids a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary pass/fail criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".  
  
Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
4. Interested bidders may obtain further information from *Partido Development Administration* and inspect the Bidding Documents at the address given below from *March 26, 2019 until April 15, 2019 at 8:00AM – 5:00PM from Monday - Friday*.
5. A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment of a non-refundable fee for the Bidding Documents in the amount of *Five Thousand Pesos Only (Php 5,000.00)*.
6. The *Partido Development Administration* will hold a Pre-Bid Conference on *April 3, 2019, 2:00 P.M. at PDA Conference Room, PDA Complex, Caraycayon, Tigaon, Camarines Sur* which shall be open to all interested parties.
