## **INVITATION TO BID** PUBLIC BIDDING

BBIDDING FOR SECURITY SERVICES (PDA/PWSS 2016-005)

- 1. The **Partido Development Administration**, through the *General Appropriations Act* intends to apply the sum of **ONE HUNDRED NINETY-TWO THOUSAND PESOS ONLY (P 192,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for the **Bidding for Security Services (PDA/PWSS 2016-005)**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The **Partido Development Administration** now invites bids for **Bidding for Security Services.** Delivery is required *from July 1, 2016 until June 30, 2017.* Bidders should have completed, within two (2) years from the date of submission and receipt of bids, a contract similar to the Project.
- 3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".
- 4. Interested bidders may obtain further information from Partido *Development Administration* and inspect the Bidding Documents at the address given below from February 18 to 29, 2016 at 8:00AM 5:00PM.

A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment of a non-refundable fee for the Bidding Documents in the amount of *Two Hundred Pesos Only (Php 200.00).* 

5. Bids must be delivered to the address below on or before February 29, 2016 at 2:00 P.M. at *Partido Development Administration*. All bids must be accompanied by a Bid Security in a form of cash or manager's check in the amount of *Three Thousand Eight Hundred Forty Pesos Only (P* 3,840.00) and Bid Securing Declaration.

Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
