INVITATION TO BID

PUBLIC BIDDING

SUPPLY OF LABOR AND MATERIALS FOR THE REHABILITATION OF RIVER INTAKE SYSTEM (PDA/PWSS 2016-011)

- The Partido Development Administration, through the General Appropriations Act intends to apply the sum of SIX HUNDRED EIGHTY SIX THOUSAND FOUR HUNDRED FIFTY PESOS ONLY (P 686,450.00) being the Approved Budget for the Contract (ABC) to payments under the contract for the Supply of Labor and Materials for the Rehabilitation of River Intake System (PDA/PWSS 2016-011). Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The **Partido Development Administration** now invites bids for **Supply of Labor and Materials for the Rehabilitation of River Intake System.** Delivery is required *within thirty (30) days after receipt of Notice to Proceed.* Bidders should have completed, within two (2) years from the date of submission and receipt of bids, a contract similar to the Project.
- 3. Bidding will be conducted through open competitive bidding procedures using nondiscretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".
- 4. Interested bidders may obtain further information from Partido *Development Administration* and inspect the Bidding Documents at the address given below from October 26, 2016 until November 7, 2016 at *8:00AM 5:00PM* from Monday Friday.

A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment of a non-refundable fee for the Bidding Documents in the amount of *Seven Hundred Pesos Only (Php 700.00)*.

5. Bids must be delivered to the address below on or before November 7, 2016 at 2:00 P.M. at *Partido Development Administration*. All bids must be accompanied by a Bid Security in a form of cash or manager's check.

Bids opening shall be on November 7, 2016 at 2:00 P.M., PDA Conference Room, Partido Development Administration, Caraycayon, Tigaon, Camarines Sur. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

6. The Bids and Awards Committee (BAC) shall use a non-discretionary and non-discriminatory measure based on sheer luck or chance, which is "DRAW LOTS", in the event that two or more bidders have been post-qualified and determined as the bidder having the Lowest Calculated Responsive Bid (LCRB) to determine the final LCRB, based on the following procedures:

- 6.1 In alphabetical order, the bidders shall pick one rolled paper.
- 6.2 The lucky bidder who would pick the paper with a "CONGRATULATIONS" remark shall be declared as the final bidder having the LCRB and recommended for award of the contract.
- 7. The *Partido Development Administration* reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
